





Approved Uses



► Treat OUD


- Narcan, Expand Recovery Centers, and Support mobile services for OUD and MH treatment.
- Prevention
 - Fund Anti-Drug Coalitions, Drug Take-Back Programs, and Educate the Public to respond to ODs.
- Other Strategies
 - Educate LEO on Precautions with Opioids, Support 1st Responders Traumatized by Opioid Events, and Track Key Opioid Indicators.

Approved Uses



- ► Treat OUD
 - County Prosecution Diversion Programs
- Other Strategies
 - Reimbursements for current law enforcement expenditures not directly related to the opioid epidemic.

Approved Uses



- ▶ Don't...
 - Comingle with general funds
 - ► Pay to fill potholes
 - Raise the salaries of staff who don't work on opioid remediation

Reporting Spreadsheet

- Reporting Spreadsheet:
 - ► What is it?
 - Intended to fulfill reporting obligations under the agreement
 - ► How will it be used?
 - ▶ Will be posted online and could be used to determine compliance
 - ► How to use it:
 - Pre-populated drop-down menus
 - ► Award / Disbursements: Dates & Amounts
 - ► Check your work!

Record Keeping

What You Must Keep:

- Contracts/MOUs
- Disbursement Receipts
- Invoices of Work Performed
- Procurement-Related Paperwork
- Grant-Related Paperwork

For How Long?

5 Years

- What happens to funds that aren't spent that year?
- ► What are options if a Local Government doesn't want the funds and/or to deal with compliance obligations?
- What happens if the State or Local Government do not use funds for Approved Purposes?
